### WHO'S FENCE IS IT?

We have received telephone calls about what to do with fences that are on the property lines. Exactly who's fence is it?

Some fences were installed by a homeowner who has since moved. Other cases involve a fence that was installed by a homeowner that is still living there. What do you do in these circumstances?

The side of the fence facing your property, is your responsibility to make sure it is clean and stained. You wouldn't want your next door neighbor to come onto your property and stain your side of the fence barn red when you want it a nice cedar color, correct?

What if the fence is old and falling down? What if the wind blows part of it over? What if slats are warping and need to be replaced?

In these instances, BOTH neighbors should pay for half of the fence repairs. It's only common sense, and makes for a more pleasant living environment.

What if a dog has caused damage to the fence? What if trees on one side are pushing the fence over? In instances such as these, the owner of the dog or the trees etc... should pay for the repairs to the fence. Again, it makes sense.

The CC&Rs state that fences in public view must look good and be maintained. This is in regard to fences that show in the front of the property. This does not affect fences that are between houses in the back yards. Talk to your neighbor about what to do with fences that need repairs in your back yard.

# **2009 Annual Meeting Minutes**

Meeting held 3/10/09 - 7pm - Ponderosa Elem

Enough homeowners did not attend the HOA meeting for a quorum, so no voting was held.

There was a presentation by president Ric Tallada. He had a slide show. He talked about the subdivision fences. They have all now been repaired and stained.

He talked about Neighborhood Watch, the Whitestone Ct. Park project, CC&R violations, our website and foreclosures.

Treasurer Dick Kluckohn reviewed the 2008 financial information and the 2009 budget. The income for 2008 was more than budgeted as collection efforts were again successful. It was annouced that the annual dues will remain the same as 2008. The HOA dues are still \$200.00 with a 50% discount when paid on time.

We received a review of the crime offenses for our subdivision. Crime again has gone down. The most common offenses are every day domestic disturbances and petit theft.

Kat Barron, our NNO coordinator spoke about the upcoming event on August 4th, and asked for some volunteers to set up and plan activities. Volunteers will meet and discuss the event and decide on which activities will be the best to make the event pleasurable and memorable for all attendees.

Upcoming violation notices were discussed. Violation letters will go out for fences with water damage, yards with weeds, trailers parked out front, garbage cans in sight, and unkempt lawns. There was a power point presentation with violation pictures.

2 gift certificates were given away at the meeting. Congratulations to the winners!

The irrigation meeting directly followed the annual meeting. The dues were increased to \$110 to make up for the rate increase in the cost of Settlers Irrigation water. The cost of the water has doubled due to a legal action they are involved in with ACHD. So far their litigation has been going on for over two years.

### **Neighborhood Watch News**

We have 15 neighborhood watch sections. Only 6 of those sections have block captains. See our website for which sections have captains.

That leaves 9 sections without block maps. Even numbered houses - Tue, Thu, Sat

In order to avoid the irrigation water pump from shutting off, try not to water during the busiest times of the day:

(Early morning and early evening)
