**NEW PROJECT** The summer project for 2018 that is scheduled to be done is to install two street lights at the front of the subdivision.

The first one will be directly behind the entrance sign. Hopefully it will allow traffic to be able to find our subdivision during the night easier. We have received many complaints over the years about how hard it is to find us on Ustick Rd. This light will also provide additional safety for children catching school buses at that intersection when the early morning is dark.

The second light will be at the other end of the island on Quarrystone Wy. and Pebblestone Ct. That intersection is very dark all night and the light will provide safety for those pedestrians walking dogs and riding bicycles etc...

### **PARKED MOTOR VEHICLES**

There have been complaints coming in to the board about cars parking in the wrong direction on the street in front of homes. Motor vehicles should be parked with the passenger side next to the right hand curb.

Title 7, Chapter 2 of the Meridian City Code states that motor vehicles should park in the direction of authorized traffic movement on 2 way streets. When vehicles are parked in the wrong direction it is a safety issue for children in the street and for cars pulling out into traffic.

### **DIRECTIONS TO PONDEROSA ELEM SCHOOL**

From Fieldstone Meadows Subdivision:

Turn Left on Ustick Rd (west) -  
Go through the Ten Mile Rd intersection -  
Turn left on Naomi Ave and drive into the  
school parking lot at 2950 N Naomi Ave

**IRRIGATION WATER** should be turned on some time after the week of April 16th.

Make sure your main valve is turned off before the water is turned on. **If you notice any water leaking or large puddles forming in your back yard please call 703-4370 ASAP.**

Our Website and Facebook page are updated when there is a period of time that the water will be shut off due to irrigation line repairs.

When too many homes try to access the water at one time, the volume of water in the well may get too low and the pump shuts off. The restart device causes the pump to turn back on 30 minutes after a shut down.

If there is no water at the time you are trying to access the system - change your schedule to water during the afternoon or after midnight when there is less demand on the system.
