2008 Annual Meeting Minutes

We had a successful annual meeting in March. We have again come a long way in the past year. House by house our subdivision is looking better and better. Fences are being stained, garbage cans are being kept out of sight and trailers are being stored behind fences...

We talked about our website and all that's included. We received a review of the crime offenses for our subdivision. There have been reports about car burglary, vandalism with paint balls and burglaries from garages and homes. For the past year crime has gone down.

We reviewed the 2007 financial information and the 2008 budget. The income for 2007 was more than budgeted as collection efforts were very successful. The association is no longer operating in the red. It was announced that the annual dues will remain the same as 2007. The dues are still \$200.00 with a 50% discount when paid on time.

We again discussed how to deal with delinquent past due homeowners. It was decided that as long as they make payment arrangements and continue to pay monthly, they will not have to pay the fines or interest, because they are making an effort. All homeowners that do not make payment arrangements or pay will be sent to a collection agency that reports to the 3 main credit bureaus.

Upcoming violation notices were discussed. Letters will go out for fences, house paint, trailers, garbage cans, and unkempt lawns. There was a power point presentation with violation pictures. There was a long discussion about changing the procedure for violation fines. Currently there are no fines charged for violations. The homeowners present decided to keep this policy in place.

A new board member was added at the meeting. Please contact us if you would like to join the board or serve on the Whitestone Ct. park committee.

Kat Barron, our National Night Out coordinator spoke about the upcoming event on August 5th, and asked for some volunteers to set up and plan activities. Volunteers will meet and discuss the event and decide on which activities will be the best to make the event pleasurable and memorable for all attendees.

The question was asked if newsletters could be emailed instead of mailed to homeowners. Newsletters are available on the website to be read anytime. Send an email to receive the link.

There was a presentation board available showing what the new park playground equipment will look like. It will be at the park on Whitestone Ct. The City of Meridian is going to pay for half of the expense of the playground equipment. This project will be done in 2009.

3 gift certificates were given away at the meeting for \$40.00 each. Congratulations to the winners!

The irrigation meeting directly followed the annual meeting. The dues were lowered to \$100 as the new pump house and access point are working well and we are saving money on electricity etc.

Neighorhood Watch

You might have noticed Neighborhood Watch signs popping up here and there. Out of 15 different sections, we have completed 4 sections and have block captains for another 6 sections.

5 sections still needing a block captain to collect the homeowner information: section 1, section 3, section 5, section 9, & section 15. A map of all the sections is located on our website.

Sections that have completed questionnaires receive maps for each participating member and a sign.
